President's Message

Arkansas ACEP Members,

During our most recent chapter annual meeting, we discussed different ways that we can do more for chapter members, how to support each other, and how we can collaborate with the residency programs and medical schools across our rural state.

One of the topics that were discussed was the increase of chapter dues. A vote took place during the annual meeting by all chapter members that were present to increase chapter dues from \$100 to \$150. The last time dues were increased was in 2008. The new rate will be more comparable to other small state chapters, yet still significantly lower than most.

Currently, the chapter has 53 Medical Students, 51 Residents, 7 Life Members, 1 Retired Member, and 101 Regular Members. At present, this dues increase will affect Regular, Retired, and Life Members.

What is a Life or Retired member?

Life Member

Any regular member who has been a member of the College for a minimum of 30-years in any class shall be assigned to life status and members in this Life Category are usually still working full time seeing patients.

Retired Member

Any member who has retired from medical practice and is no longer seeing patients, may upon application to the Board of Directors, be elected to retired membership.

This dues increase will provide some equity between a few member categories with the objective of increasing more legislative initiatives and additional chapter goals to improve Emergency Medicine in Arkansas. The Chapter Board will continue to diligently do what is best for its members and Emergency Medicine in Arkansas.
